*This sales contract is a purchase agreement between the Purrbastet Cattery (Seller) and ***** (buyer). Both parties agree to the following terms:*

The cat/kitten will come with appropriate documentation of immunizations, de-worming and TICA or CFA registration. The cat/kitten is guaranteed to be of good health upon delivery, the seller does not cover any conditions or disease contracted after the cat/kitten has left the premises. Purchaser agrees to provide appropriate care and shelter in proportion to the needs of this breed.

Purchaser agrees to provide adequate health and care for the cat/kitten. Seller guarantees the health of the kitten/cat for 3 days after transfer to purchaser. Purchaser agrees to have the kitten/cat examined by license veterinary within 72 hrs. Purchaser is responsible for all veterinary fees after date of shipping/pickup. The Sphynx, ELF, Bambino, or Dwelf is an indoor cat only. Seller will guarantee cat/kitten for a term of 2 years for genetic illness and HCM, resulting in death within its first 2 years of life. Necropsy, pictures of corpse, lab work, veterinarian summary will be required in support of diagnosis; failure to produce documentation voids guarantee. Guarantee is fulfilled by replacing said cat/kitten with a cat/kitten on equal value. If no kitten is available the buyer will be placed on a waiting list (for a time no greater than 8 months). Breeding cats are scanned for HCM, however HCM can develop at any age. The hairless breed is known to have heart issues and you must be aware and agree to the special needs of this unique breed. Thus, by default, in completing this adoption the buyer acknowledges these health issues. It is NOT the breeders responsibility to educate the buyer about the breed. It is the buyers responsibility to educate themselves about the breed and provide any and all care that may arise from adoption.

Waiting list deposit of \$100, are refundable, however, once the waiting list deposit is applied toward the reservation deposit for a cat/kitten, it is NONREFUNDABLE. A deposit is required (per)cat/kitten to place a hold or reservation. Deposit amounts: \$400 Sphynx, \$500 Elf, \$600 Bambino or Dwelf. Exchanges before but not after one week of placing a reservation on a particular cat are permitted. If the buyer, having put a deposit on a cat/kitten, should later change their mind about the purchase, **THE DEPOSIT IS NONREFUNDABLE**. Cat/Kittens are living beings, as such if cat/kitten should die before the buyer picks up the cat/kitten, Purr-Bastet will replace it with one of equal quality or value. If no kitten is available the buyer will be placed on a waiting list (for a time no greater than 8 months). Should the buyer decide not to purchase the cat/kitten provided in replacement, it is understood that **THE DEPOSIT IS NONREFUNDABLE**. After cat/kitten goes home THERE ARE NO REFUNDS. Seller reserves the right to cancel a sale/contract of any cat/kitten. In such an event, the deposit will be refunded to the buyer.

In the event that the cat/kitten will be shipped out to the buyer, the buyer understands that they will always be responsible for paying the shipping cost. Once cat/kitten is handed over to the airline, courier or pet nanny, the buyer takes all responsibility to deal with them directly if the cat/kitten is lost, stolen or damaged resulting harm and or the mortality of the cat/kitten.

The buyer understands that the cat/kitten is being sold exclusively as a pet, unless otherwise specified. Kitten is Spayed or neuter prior to re-homing, in the event the kitten is not neutered or spayed, buyer must due so prior to 6 months of age and provide proof to seller. Breeders/Showkittens or cats are sold with rights and no guarantee they will produce or place within a show. It is understood that show quality, personality, weight, eye color, color, breeding capability or any other characteristics of nature are not guaranteed. However, seller will do their best to make as similar of a match to the desired characteristics whenever possible. Purr-Bastet reserves the right to price odd eye cats/kitten at a non-pet price.

The buyer understands the kitten/cat is not hypoallergenic. It is understood that although they appear to be hairless, it is not truly hairless. Fur on tail, feet, and face are common. The degree of hairlessness of the breed varies from cat to cat. Buyer agrees to quarantine the cat for 15 days and not transition into a new diet until end of quarantine.

It is understood that by simply realizing the adoption from our cattery, the buyer has read our "Basic Kitten Care" as posted on our website and agreed to all stipulations on this contract. Purchaser's signature indicates full agreement of all the terms and conditions of the purchase contract. This document is a legal and binding contract, any legal disputes must be filed and brought to the Imperial county court located in the state of California.
